ORDINANCE NO. 21-S2010

AN ORDINANCE AMENDING SECTION 51.01, ARTICLE I OF MUNICIPAL ORDINANCE NO. 05 - SERIES OF 2000 CODIFYING THE REVENUE ORDINANCE OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, upon approach of the Business Permits and License Office, an endorsement to this office from the Honorable Mayor Domingo G. Panganiban was tackled and discussed by this august body requesting for the amendment of Section 51.01, Article 1 of Municipal Ordinance No. 05-Series of 2000 entitled Codifying the Revenue Ordinance of the Municipality of Santa Cruz, Laguna;

WHEREAS, the said request was endorsed to the Committee on Finance and the Committee on Laws of this sanggunian for further deliberation, highlighting the importance of increasing the amount imposed in the collection of sticker fee for business enterprise due to high cost of production of the business plates;

WHEREAS, after careful and thorough study of the said request, this body deemed it proper to amend the said section of the ordinance.

WHEREFORE, on motion of Honorable Councilor Rizaldy N. Kalaw, (Chairman on Committee on Laws), duly seconded by Honorable Councilor Serafin C. San Juan, Jr. and with the unanimous consent of all the members present it was

RESOLVED: To amend Section 51.01, Article 1 of Municipal Ordinance No. 05 - Series of 2000 - Codifying the Revenue Ordinance of the Municipality of Santa Cruz, Laguna as follows:

Be it ordained by the Honorable Sangguniang Bayan of Santa Cruz, Laguna that:

SECTION 1 - To amend the following:

ARTICLE I Sticker Fee

SECTION 51.01 - Imposition of Fee - There shall be collected a sticker fee from the following :

a. Business	P 40.00
b. Tricycle	30.00

and be replaced and corrected as follows:

ARTICLE I
Sticker Fee and Business Plate Fees

SECTION 5I.01 – Imposition of Fee – There shall be collected a sticker and business plate fees for the following:

SECTION 2 – This ordinance shall take effect upon approval.




