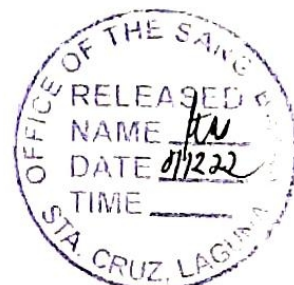

**RESOLUTION NO. 001- S2022**

**A RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF SENATOR CHRISTOPHER LAWRENCE "BONG" TESORO GO TO BE DISTRIBUTED TO THE CONSTITUENTS OF THE MUNICIPALITY OF SANTA CRUZ LAGUNA TO COUNTER THE EFFECTS OF PANDEMIC.**

**WHEREAS**, Section 15 Article II under the Declaration of Principles of the 1987 Philippine Constitution states that "The State shall protect and promote the right to health of the people and instill consciousness among them";

**WHEREAS**, the National Government has announced an Enhanced Community Quarantine measure on 16 March 2020 to be implemented for the whole Luzon region;

**WHEREAS**, one of the strict directives of the measure is to restrict the movement of individuals outside of their home which would substantially prevent the low-income families especially the poorest and most vulnerable families from earning a daily wage and impacts severely their ability to fight off Corona Virus Infectious Disease – 2019 (COVID-19) putting them at risk of infection as well as others;

**WHEREAS**, the National Government has released Ayuda under Social Amelioration Program – Emergency Subsidy Program (SAP-ESP) 1 and 2 which is inadequate to reach out some sectors of our Municipality. Hence, the request of financial assistance which aimed to be distributed to the following:

1. Solo parents specifically unmarried mother
2. Senior Citizens which has no source of income, if ever short of income to buy their necessities and medicine
3. Those individuals who are taking care of children of mothers who are working but with no or little compensation for their effort
4. Those qualified individuals who did not receive *Ayuda* within the last 3 months
5. Other similar sectors that will be directed by the Office of Senator Go that will be qualified for the assistance.

**WHEREAS**, this request of financial assistance is to give aid to families who are ill-equipped with goods and capital in order to combat the COVID-19 pandemic and sustain themselves during the implementation of the Enhance Community Quarantine ( we are declared on Alert Level 3), measure by the National Government;

**NOW THEREFORE**, on motion of Hon. Louie C. De Leon (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Ramon D. Tan, Hon. Lucena R. Odejar, Hon. Mark Anthony P. Joven and Hon. Efren L. Diaz, and with the approval of the members of the Sangguniang Bayan, it was
