MUNICIPAL ORDINANCE NO. 02- S2022

AN ORDINANCE CREATING THE POSITIONS OF NURSE I WITH SALARY GRADE 15 AND NURSE II WITH SALARY GRADE 17 IN THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA UPGRADING THE ENTRY LEVEL OF THE POSITION OF NURSE PURSUANT TO DEVOLUTION AND TRANSITION PLAN.

WHEREAS, pursuant to DBM Local Budget Circular 2009-92 provides for the upgrading the Entry Level of Nurse Positions as well as to modify position classification in every LGU in accordance with Devolution and Transition Plan;

WHEREAS, an endorsement from Municipal Mayor Hon. Edgar S. San Luis dated December 2, 2021 was respectfully forwarded to Honorable Sangguniang Bayan members requesting for the creation of the position of Nurse 1 (SG15) and Nurse II (SG-17) in the Municipal Health Office as endorsed by Human Resource Management Officer to re-allocate said position effective January 3, 2022;

WHEREAS, the endorsement was referred to the Committee on Good Governance, Public Ethics and Public Accountability for study and evaluation;

WHEREAS, after thorough evaluation of the Committee it is recommended for its approval;

NOW THEREFORE, on motion of Hon. Patrocinia S. Kalaw (Chairman of Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by Hon. Ambiel John C. Panganiban and Hon. Lucena R. Odejar and with the approval of all the members of the Sangguniang Bayan, it was

Be it ordained by the Sangguniang Bayan of Santa Cruz, Laguna in session assembled that :

SECTION 1. There is hereby created in the Plantilla Position for one (1) Nurse 1 with Salary Grade 15 and one (1) Nurse II with Salary Grade 17 in the Municipal Health Office of the Municipal Government of Santa Cruz, Laguna as included in Devolution and Transition Plan and to re-allocate the position of the Personnel effective January 3, 2022 from Public Health Nurse 1 (SG-16) to Nurse 1 (SG 17) and Public Health Nurse II (SG-16) to Nurse II (SG-17).

SECTION 2. Qualifications for the said positions shall be based on the standards set for the Civil Service Commission.

SECTION 3 Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 4. Repealing Clause. All Ordinances local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5 Effectivity Clause. This Ordinance shall be effective upon approval thereof.

ORDERED. Let copies of this ordinance be furnished the Honorable Sangguniang Panlalawigan, the Honorable Mayor, the Municipal Treasurer, the Municipal Budget Officer, the Municipal Accountant, the Municipal Planning and Development Coordinator, the Human Resource Management Officer, the Rural Health Unit, Civil Service Commission, and all other concerned offices, for their information and appropriate action.




