RESOLUTION NO. 155- S2022

A RESOLUTION REQUESTING ASSISTANCE FROM THE PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION THRU THE RICE COMPETITIVENESS ENHANCEMENT FUND-MECHANIZATION COMPONENT BASIC PRODUCTION AND POSTHARVEST FACILITIES FOR THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, the Municipal Government of Santa Cruz Laguna having control over all aspects of palay and rice industry can advance its agricultural development;

WHEREAS, in order to improve its productivity and save postharvest losses, the Municipal Government of Santa Cruz Laguna needs to acquire basic production and postharvest facilities such as:

2 units Recirculating Dryer – first priority
1 unit Multi-Pass Rice Mill – second priority

WHEREAS, the Municipality of Santa Cruz Laguna has a total of 1,306 hectares of irrigated and 8.3 hectares non-irrigated rice land and 906 farmers that will directly benefit from this project and has access to the services of expert personnel to manage and operate the said machinery/facilities;

WHEREAS, as initial operating cost the Municipal Government of Santa Cruz, Laguna will put up TWO MILLION (Php 2,000,000.00) pesos which will serve as revolving fund for the maintenance of said machinery;

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Chairman, Committee on Agriculture, Fisheries and Cooperative), duly seconded by Hon. Louie C. De Leon, Hon. Lucena R. Odejar and Hon. Ambiel John C. Panganiban and with the approval of the members of the Sangguniang Bayan present, it was

RESOLVED, as it is hereby RESOLVED: To request ASSISTANCE FROM THE PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION THRU THE RICE COMPETITIVENESS ENHANCEMENT FUND-MECHANIZATION COMPONENT BASIC PRODUCTION AND POSTHARVEST FACILITIES FOR THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

RESOLVED FURTHER, that the Honorable Mayor Edgar S. San Luis of the Municipality of Santa Cruz, Laguna shall be designated as the authorized representative to transact with the DA-PHILMECH to sign documents for and in behalf of the Municipal Government of Santa Cruz, Laguna with respect to the requested assistance.

ORDERED: Let copies of this resolution be furnished the Honorable Mayor, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development, the Municipal Accountant, the Municipal Agriculture Office; DA-PHILMECH and all other concerned offices, for their information and appropriate action.
