**RESOLUTION NO. 234- S2022**

**A RESOLUTION GRANTING AUTHORIZATION TO HONORABLE MUNICIPAL MAYOR EDGAR S. SAN LUIS TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA A MEMORANDUM OF AGREEMENT WITH RHENZ EMILLE FUNERAL PARLOR DULY REPRESENTED BY MICHELLE T. BALUBAYAN AS SERVICE PROVIDER FOR THE MANAGEMENT OF HUMAN REMAINS OF COVID 19 RELATED CASES THIS MUNICIPALITY.**

**WHEREAS**, the Municipal Government of Santa Cruz, Laguna through the effort of the Municipal Disaster Risk Reduction and Management Officer (MDRRMO) is directed to forge agreements with the private sector that will ensure adequate supply of goods, medicines, necessary service/s and immediate use of facilities and resources during and in the aftermath of disaster, calamity or communicable disease;

**WHEREAS**, in order to perform such functions so as to support and promote the health and safety of the inhabitants in handling the remains of those affected or confirmed covid 19, the MDRRMO is hereby directed to look for a service provider which desires and warrants the delivery of services and the Municipality to agree to secure the same for a consideration that maybe agreed upon hereto and under the terms and conditions herein set forth;

**WHEREAS**, after careful study and due evaluation of the Sangguniang Bayan deemed it proper to grant an authority to Honorable Mayor Edgar S. San Luis to enter into Memorandum of Agreement with Emilia T. Balubayan or Michelle T. Balubayan under Rhenz Emille Funeral Parlor with the foregoing considerations:

1. That the Memorandum of Agreement shall be effective during the entire period of community quarantines and until the service provider commits for the management of human remains of covid 19 patients and persons under investigation and in accordance with the standards set forth by DOH and MHO unless terminated by either party.
2. That the Municipal Government of Santa Cruz, Laguna agrees to pay the service provider in the amount of THIRTY FIVE THOUSAND PESOS (Php 35,000.00) for every services delivered chargeable to the 30% Quick Response Fund (QRF) of MDRRM fund.

**NOW THEREFORE**, on motion of Honorable Louie C. De Leon (Vice-Chairman of Committee on Social Welfare and Development, Family and Women), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Efren L. Diaz and Hon. Mark Anthony P. Joven with the unanimous approval of the members of Sangguniang Bayan, it was
