A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER INTO AND SIGN A DEED OF DONATION FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY DULY REPRESENTED BY JAIL SENIOR INSPECTOR JAY TEE TANTANGCO, RELATIVE TO THE DONATION OF LAND WITH PROPERTY IDENTIFICATION NO. 023-25-0009-002-58 UNDER TAX DECLARATION NO. 25-0-0009-05380 WITH AN AREA OF MORE OR LESS TWO THOUSAND FOUR HUNDRED SIXTY (2,460) SQUARE METER AND ALL PERTINENT DOCUMENTS RELATIVE THERETO SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Municipal Government of Santa Cruz, Laguna is the owner of the property with Tax Declaration (TD) No. 25-0009-05380 with property identification No. 023-25-0009-002-58 and with an area of more or less 2460 square meter which is undeveloped residential located at Barangay Calios, Sta. Cruz, Laguna;

WHEREAS, a request from Jail Senior Inspector District Jail Warden of the Bureau of Jail Management and Penology (BJMP) – Santa Cruz asking for the donation of a vacant lot beside/adjacent to the present jail unit located at Barangay Calios, Santa Cruz, Laguna;

WHEREAS, upon inspection and submission of vicinity map including all pertinent documents, the August Body conformed on the grant of authority to the Local Chief Executive and sign the Deed of Donation for its purpose;
