RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA A MEMORANDUM OF AGREEMENT (MOA) TO NEGOTIATE WITH PAGCOR SOCIO-CIVIC PROJECT FUND (SCPF) OF THE OFFICE OF THE PRESIDENT DULY REPRESENTED BY ITS EXECUTIVE SECRETARY SALVADOR C. MEDIALDEA CONCERNING THE ASSISTANCE TO INDIGENT INDIVIDUALS OR FAMILIES IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA AMOUNTING TO FIVE MILLION PESOS (PHP 5,000,000.00).

WHEREAS, the Local Chief Executive Hon Edgar S. San Luis has applied for financial assistance to the National Government chargeable against PAGCOR Socio-Civic Project Fund of the Office of the President in order to cater and address the needs of the people affected by pandemic within its jurisdiction, to wit

- Assistance to indigent individual or families in the following forms :
 - a. Medical
 - b. Burial
 - c. Transportation
 - d. Food Assistance
 - e. Cash for Work
 - f. Educational Assistance
- Budget – Php 5,000,000.00

WHEREAS, in order for the release of funds it requires an authorization from the August Body for its implementation and hereby included in the approved Annual Investment Plant FY 2022 of the Municipal Government of Santa Cruz, Laguna;

WHEREAS, said request was deliberated upon by members of the Sangguniang Bayan thereby recommending for its approval.
