

**RESOLUTION NO. 205 - S2021** 

A RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET OF THE GENERAL FUND FOR CALENDAR YEAR 2021 IN THE AMOUNT OF SEVENTEEN MILLION SEVEN HUNDRED THIRTY EIGHT THOUSAND NINETY SIX PESOS AND EIGHTY SIX CENTAVOS (Php 17,738,096.86) OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO BE USED FOR THE IMPLEMENTATION OF SALARY STANDARDIZATION SECOND TRANCHE (LBC NO. 132) AND VARIOUS EXPENSES HEREOF SUBJECT TO ALL LEGAL LAWS, ACCOUNTING AND AUDITING RULES AND REGULATIONS.

WHEREAS, the Sangguniang Bayan Office received a proposed Supplemental Budget Calendar Year 2021 in the amount of Seventeen Million Seven Hundred Thirty Eight Thousand Ninety Six Pesos and Eighty Six Centavos (Php 17,738,096.86) in an endorsement dated March 18, 2021 for review and approval;

WHEREAS, the said amount covered the programs, projects and employees benefits and other various expenses to support the needs of the community in times of pandemic which were given priority by the Municipal Government;

WHEREAS, said request for supplement budget CY 2021 was referred to the Committee on Finance, Budget and Appropriation for study and evaluation;

WHEREAS, a certification as to the availability of fund was issued by the Municipal Accountant and Municipal Treasurer to support the approval of the Supplemental Budget of the General Fund for CY 2021;

WHEREAS, after careful evaluation and thorough study by the Committee, it is recommended that the request be APPROVED in compliance with Local Budget Circular No. 132 and found to be in accordance with the general policies and requirements and existing regulations have been fully satisfied and complied with;

NOW THEREFORE, on motion of Honorable Louie C. De Leon (Chairman of the Committee on Finance, Budget and Appropriation), duly seconded by all the members of the Sangguniang Bayan, it was

Be it ordained by the Sangguniang Bayan of Santa Cruz Laguna in its session assembled that

SECTION 1.
