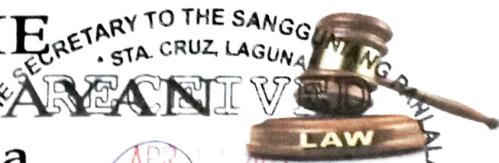

A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PLAN (SIP) IN THE AMOUNT OF SEVENTEEN MILLION SEVEN HUNDRED THIRTY EIGHT THOUSAND NINETY SIX PESOS AND EIGHTY SIX CENTAVOS (Php 17,738,096.86) AN APPROPRIATION FROM THE SURPLUS OF 2020 GENERAL FUND TO BE SUPPLEMENTED IN THE 2021 ANNUAL BUDGET AND THE ANNUAL INVESTMENT PLAN INCLUDING THE CREATION OF NURSES (2) AND NURSING ATTENDANT.

WHEREAS, an endorsement from Honorable Mayor Edgar San Luis of Santa Cruz Laguna certified as urgent requesting for appropriation from 2020 surplus from the General fund to be supplemented in the 2021 Annual Budget and Annual Investment Plan in the amount of Php 17,738,096.86;

WHEREAS, it was referred and deliberated upon by the Committee on Finance, Budget and Appropriation and hereby recommend its approval;
