## **RESOLUTION NO. 230 - S2021**

RESOLUTION ADOPTING THE FORMULATION AND IMPLEMENTATION OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN FOR THE PERIOD 2020-2022 OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA AND THE CONTINGENCY PLAN FOR FLOOD 2020-2022 SUBJECT TO APPLICABLE LAWS, RULES AND REGULATION.

WHEREAS, pursuant to Section 12 of Republic Act 10121 or the Philippine Disaster Risk and Reduction and Management Act of 2010, it is the function of the Local Disaster Risk Reduction and Management Council (LDRRMC) to manage the adverse effects of any disaster. It mandates the LDRRMC to take the lead in preparing for responding to and recovering from the adverse effects of any disaster, to strengthen its capacity towards mitigation, preparedness, response and recovery to reduce risks to human life and assets, and build disaster resilient communities;

WHEREAS, the formulation and implementation of the contingency plan for flood 2020-2022 of the Municipal Government of Santa Cruz, Laguna is anchored on scientific knowledge and deep understanding of the Municipality's hazards, vulnerability and risk reduction to human induced or natural disaster or calamities and has undertaken a collaborative and comprehensive planning process for addressing preparing, mitigating and preventing the effects of various forms of disaster and emergency situations;

WHEREAS, on February 16, 2021, an endorsement was forwarded to the Honorable Sangguniang Bayan for appropriate action the Local Disaster Risk Reduction and Management Plan for the period 2020-2022 and the contingency plan for flood 2020-2022 of the Municipality of Santa Cruz, Laguna;

WHEREAS, it is the policy of the Municipal Government of Santa Cruz, Laguna to formulate and adopt a contingency plan of preparation, prevention and mitigation in case of emergency and natural catastrophe and through this Disaster Preparedness Contingency Plan, we can now direct our actions, programs and projects toward an effective, doable and systematic contingency preparation and responsive capability for any disastrous eventuality;

WHEREAS, in recognizing the possible occurrence of typhoons, earthquake and acknowledging the need to prepare for a worst case science based scenario, the Municipal Government of Santa Cruz, Laguna Disaster Risk Reduction and Management Council crafted and formulated the Contingency Plan for Flood with series of participatory and consultative meetings and consultation with experts and stakeholders.

**WHEREAS**, said endorsement was referred to the Committee on Environment and Natural Resources for study and evaluation;

**WHEREAS**, after due evaluation and deliberation, it is hereby recommended by the committee for its approval;

NOW THEREFORE, on motion of Hon Mark Anthony P. Joven (Committee on Natural Resources and Environment), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Ramon D. Tan, Hon. Efren L. Diaz and Hon. Lucena R. Odejar, with the approval of all the members of the Sangguniang Bayan, it was
