



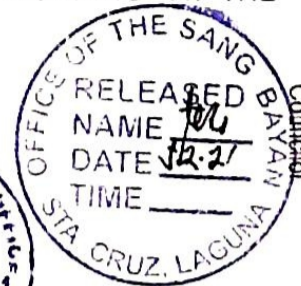

WHEREAS, the Municipal Development Council through Kapasiyahan Blg. 3-T2021, endorsed to this Body for review and adoption of the programs and projects regarding Revitalization of Agri-livestock and Poultry Industry (Cattle Raising, Duck Raising, Egg Raising) a fund from Local Government Support Fund – Disaster Rehabilitation and Reconstruction Assistance Program (LGSF-DRRAP) FY 2021 in the amount of Two Million Two Hundred Ninety Two Thousand Three Hundred Fifty Five Pesos (Php2,292,355.00) for the Municipality of Santa Cruz, Laguna;

WHEREAS, the Municipal Government of Santa Cruz, Laguna is a recipient of the Local Government Support Fund-Disaster Rehabilitation and Reconstruction Assistance Program (LGSF-DRRAP) through Department of Interior and Local Government (DILG) which mandates to allocate programs and projects for the needs of the general welfare;

WHEREAS, said Municipal Development Council Kapasiyahan was referred to combined Committee on Agriculture, Fisheries and Cooperative, Committee on Livelihood & Industry and Committee on Finance, Budget and Appropriation for evaluation;
