## RESOLUTION NO. 248 - S2021

A RESOLUTION MODIFYING AND ADJUSTING THE PROGRAMS EMBODIED IN MDC KAPASIYAHAN BLG 5-T2021 APPROVED BY EXECOM PURSUANT TO MDC KAPASIYAHAN BLG 6 T2021 UNDER THE CONTINUING FUND OF 20% MUNICIPAL DEVELOPMENT FUND 2021 AMOUNTING TO Php18,027,338.73 OF THE MUNICIPALITY OF SANTA CRUZ LAGUNA.

**WHEREAS**, there is a need for the Municipal Government of Santa Cruz Laguna to modify and make some adjustments on the projects and programs considered priority under continuing fund of 20% 2021 which really need to be carried out and more helpful to the needs of the people and community as well;

**WHEREAS**, after thorough review during the EXECOM meeting of the MDC it resolves to approved the modification and adjustment made under the 20% continuing fund amounting to Php 18,027,338.73 of the Municipal Government of Santa Cruz Laguna as to priority projects and programs which needed to implement for the good of the people and community;

**WHEREAS**, Kapasiyahan Blg 6T2021 was referred to combined Committee on Public Works, Infrastructure and Electrification, Committee on Good Governance Public Ethics and Accountability and Committee on Finance, Budget and Appropriation for study and evaluation;

**WHEREAS**, after due evaluation, the Committee recommends the approval of Kapasiyahan Blg 6T-2021 under continuing fund of 20% MDF amounting to Php 18,027,338.73.
