**RESOLUTION AUTHORIZING HONORABLE MAYOR EDGAR S. SAN LUIS, LOCAL CHIEF EXECUTIVE OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH DENR-ENVIRONMENTAL MANAGEMENT BUREAU DULY REPRESENTED BY ITS DIRECTOR, ENGR WILLIAM P. CUÑADO FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF SOLID WASTE MANAGEMENT EQUIPMENT CONSISTING OF BIODEGRADABLE WASTE SHREDDER AND COMPOSTER TO SUPPORT THE MUNICIPALITY OF SANTA CRUZ, LAGUNA CONCERNING SOLID WASTE MANAGEMENT AND PURSUANT TO REPUBLIC ACT 9003.**

**WHEREAS**, an endorsement dated March 8, 2021 was forwarded and received by Honorable Sangguniang Bayan from Honorable Mayor Edgar S. San Luis asking an authority to enter and sign the Memorandum of Agreement with DENR-EMB for the supply, delivery, installation, testing and commissioning of Solid Waste Management equipment consisting of biodegradable waste shredder and composter to support the Municipality of Santa Cruz, Laguna and pursuant to Republic Act No. 9003 otherwise known as "Ecological Solid Waste Management Act of 2000";

**WHEREAS**, to enhance the target of Local Government Units capacity to address issues concerning Solid Waste Management within its jurisdiction the provision of Biodegradable Waste Shredder and Composter is needed for the implementation of RA 9003 and to contribute toward Social and Economic Development in our country,

**WHEREAS**, the endorsement was referred to the Committee on Environment and Natural Resources, Committee on Laws and Ordinances, Committee on Health, Nutrition and Sanitation and Committee on Peace and Order for study, evaluation and recommendation;

**WHEREAS**, after careful evaluation, the committee hereby recommends to authorize the Honorable Mayor Edgar S. San Luis to enter and sign the Memorandum of Agreement with DENR-EMB;

**NOW THEREFORE**, upon motion of Honorable Mark Anthony P. Joven (Chairman of Committee on Environment and Natural Resources), duly seconded by Hon. Lucena R. Odejar and Hon. Ambiel John C. Panganiban, and with the approval of all the members of the Sangguniang Bayan, it was

**RESOLVED**, to authorize and empower the Local Chief Executive, Hon. Edgar S. San Luis for and in behalf of the Municipality of Santa Cruz, Laguna to undertake the following :

- Provide suitable site for installation of the said equipments.
- Assign at least three(3) personnel to manage the operation of the equipment.
- Ensure that the equipment are continuously utilized on a daily basis.
- Ensure the sustainability of the project implementation through proper utilization and maintenance of the equipment.
- Guarantee proper and effective operation of the equipment.
- In case of equipment malfunction/breakdown, provide/allocate enough funds to cover the expenses for repairs and other incidental costs to restore the immediate operation of the equipment.
