A RESOLUTION APPROPRIATING AN AMOUNT OF FOUR MILLION SEVEN HUNDRED THREE THOUSAND EIGHT HUNDRED NINETY PESOS AND FOUR CENTAVOS (PHP 4,703,890.04) RECEIVED FROM MERALCO TO BE UTILIZED FOR CASH ASSISTANCE / EMERGENCY SUBSIDY / AYUDA FOR THE VULNERABLE AND AFFECTED RESIDENTS OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA AND SUBJECT TO LEGAL LAWS, RULES AND REGULATIONS

WHEREAS, presented to the Honorable August Body a request from Hon Mayor Edgar S. San Luis dated April 29, 2021 through the Local Finance Committee of the Municipal Government of Santa Cruz Laguna for a special session for the purpose of appropriating the amount of Php4,703,890.04 Miscellaneous income from Meralco intended as emergency subsidy which will cover those constituents who will not qualify for the ayuda extended by the National Government in time of the declaration of Enhanced Community Quarantine and during this time of Pandemic;

WHEREAS, the said miscellaneous income from Meralco represent the 75% generated revenue/refund fund of the Municipal Government of Santa Cruz, Laguna advance from projects such as DGP 1, DGP 2 (Brgy Oogong), Brgy Alipit and some other upgrading facilities within the Municipality for the previous years;

WHEREAS, as discussed during the special session it was reiterated that an advise coming from Meralco last year (2020) that an amount will be refunded to the Municipal Government Of Santa Cruz, Laguna which was treated as Miscellaneous Income /Accounts Receivables until a check was received and issued dated February 11, 2021 pay to the order of the Municipality of Santa Cruz in the amount of Php4,703,890.04 and was entered as Cash Surplus this year 2021;

WHEREAS, the Municipal Government has allocated earlier P3,000,000.00 as emergency subsidy aside from the P98 Million coming from the National Government and the Miscellaneous Income from Meralco;

WHEREAS, there is a need to revert the above mentioned amount to the appropriated Surplus of the General Fund so that it may be made available for expenditure for supplemental appropriation on Maintenance and Other Operating Expenses;

NOW THEREFORE, upon motion of Hon. Louie C. De Leon (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by all members of the Sangguniang Bayan present,
