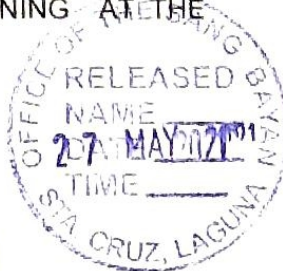

**RESOLUTION AUTHORIZING HONORABLE MAYOR EDGAR S. SAN LUIS, LOCAL CHIEF EXECUTIVE OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ LAGUNA TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH GLOBAL ENVIRONMENT TECHNOLOGIES AND GENERAL SERVICES INC. (GEMTECH) DULY REPRESENTED BY ITS PRESIDENT BERNABE S. BARCO FOR PROPER COLLECTION, TRANSPORT AND DISPOSAL OF SOLID WASTE MATERIALS FROM WITHIN THE JURISDICTION OF THE MUNICIPALITY OF SANTA CRUZ LAGUNA AND PURSUANT TO REPUBLIC ACT NO. 9003 SUBJECT TO LEGAL LAWS, RULES AND REGULATION**

**WHEREAS**, an endorsement dated February 5, 2021 was forwarded and received by Honorable Sangguniang Bayan from Honorable Municipal Mayor Edgar S. San Luis asking an authority to enter and sign the Memorandum of Agreement with Global Environment Technologies and General Services Inc. (GEMTECH) for proper collection, transport and disposal of Solid Waste Materials within the jurisdiction of the Municipality of Santa Cruz, Laguna and pursuant to Republic Act No, 9003 otherwise known as "Ecological Solid Waste Management Act of 2000";

**WHEREAS**, said Local Government Units are given direct responsibility in the strict implementation of Solid Waste Management particularly the safe waste collection, disposal of solid waste materials within its vicinity taking into account the safety of the inhabitants within then community/barangays and maintenance of the users road;

**WHEREAS**, the endorsement was referred to the Committee on Environment and Natural Resources and Committee on Finance, Budget and Appropriation for study, evaluation and recommendation;

**WHEREAS**, after careful evaluation, the committee hereby recommends to authorize the Honorable Mayor Edgar S. San Luis to enter and sign the Memorandum of Agreement with GEMTECH;

**NOW THEREFORE**, upon motion of Honorable Mark Anthony P. Joven (Chairman of Committee on Natural Resources and Environment), duly seconded by Hon. Lucena R. Odejar and Hon. Ambiel John C. Panganiban and with the approval of all the members of the Sangguniang Bayan, be it:

**RESOLVED as it is hereby, RESOLVED** to authorize the Honorable Mayor Edgar S. San Luis to enter and sign a Memorandum of Agreement with Global Environment Technologies and General Services, Inc. (GEMTECH) duly represented by its President Bernabe S. Barco for proper Collection, Transport and Disposal of Solid Waste Materials from within the Jurisdiction of the Municipality of Santa Cruz, Laguna and pursuant to Republic Act No. 9003 subject to Legal Laws, Rules and Regulation.

**ORDERED:** Let copies of this resolution the Honorable Mayor, the Municipal Treasurer, the Municipal Budget Officer, the Municipal Accountant, the Municipal Planning and Development Coordinator; the Municipal General Officer, Mr. Bernabe Barco of GemTech and all other concerned offices, for their information and appropriate action.
