**A RESOLUTION COMMENDING RECOGNITION TO LUPONG TAGAPAMAYAPA OF BARANGAY OOGONG SANTA CRUZ LAGUNA FOR ITS EXEMPLARY PERFORMANCE IN THE OBSERVANCE OF SETTLEMENT OF PROCEDURE AND CONDUCT OF SETTLEMENT TECHNIQUE PURSUANT TO DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT - LUPON TAGAPAMAYAPA INCENTIVE AWARDS**

**WHEREAS**, the Lupong Tagapamayapa Incentive Awards (LTIA) of the Department of Interior and Local Government pursuant to Executive Order 394 aims to institutionalize a system of granting economic benefits to outstanding lupon to strengthen the Katarungang Pambarangay created pursuant to Section 399 of Republic Act 7160 as an indigenous structure at the grassroots and generate awareness as a vehicle toward Social Order and Human Development;
