



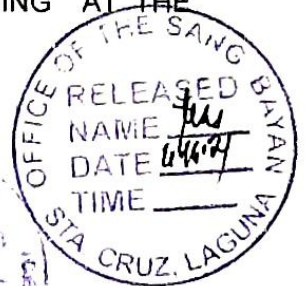

**RESOLUTION NO. 298 -S2021**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. EDGAR S. SAN LUIS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA WITH THE PROVINCIAL GOVERNMENT OF LAGUNA DULY REPRESENTED BY HON. RAMIL L. HERNANDEZ, PROVINCIAL GOVERNOR REGARDING THE FUND ASSISTANCE IN THE AMOUNT OF ONE MILLION PESOS (Php1,000,000.00) FOR PROJECT COMMUNITY DEVELOPMENT PROGRAM FOR 1<sup>ST</sup> TO 4<sup>TH</sup> QUARTER CY 2021, SUBJECT TO ALL LEGAL LAWS, RULES AND REGULATIONS.**

**WHEREAS**, on March 9, 2021, the Sangguniang Bayan received an endorsement from Melvin O. Bonza, Municipal Administrator by authority of the Honorable Mayor Edgar San Luis requesting for a resolution authorizing the Honorable Mayor to enter and sign a Memorandum of Agreement (MOA) with the Provincial Government regarding fund assistance in the amount of One Million Pesos for project Community Development Program for the 1<sup>st</sup> to 4<sup>th</sup> quarter CY 2021;

**WHEREAS**, said endorsement was referred to Committee on Finance, Budget and Appropriation for evaluation;

**WHEREAS**, after due evaluation and deliberation said Committee recommended to approve a resolution authorizing Honorable Edgar S. San Luis to enter and sign the Memorandum of Agreement with the Provincial Government of Laguna for the project Community Development Program for the 1<sup>st</sup> to 4<sup>th</sup> quarter CY 2021 in the amount of One Million Pesos (Php1,000,000.00).

**NOW THEREFORE**, on motion of Hon. Louie C. De Leon (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by all the members of the Sangguniang Bayan, it was

**BE IT RESOLVED**, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN OF SANTA CRUZ LAGUNA BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION ASSEMBLED, A resolution authorizing the Local Chief Executive Hon. Edgar S. San Luis to enter and sign the Memorandum of Agreement (MOA) in behalf of the Municipality of Santa Cruz, Laguna with the Provincial Government of Laguna duly represented by Hon. Ramil L. Hernandez Provincial Governor, regarding the fund assistance in the amount of One Million Pesos (Php1,000,000.00) for the project Community Development Program for the 1<sup>st</sup> to 4<sup>th</sup> quarter CY 2021 subject to all legal laws, rules and regulations.
