



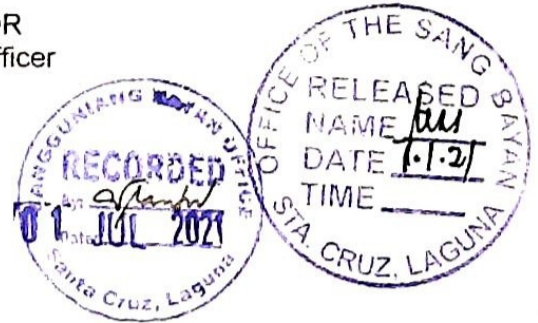

RESOLUTION GRANTING AUTHORITY TO HON. EDGAR S. SAN LUIS TO ENTER AND SIGN IN BEHALF OF RURAL HEALTH UNIT OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA AND DRA. ELMINA DL. MONTEZA, MUNICIPAL HEALTH OFFICER, WITH LAGUNA MEDICAL CENTER, REPRESENTED BY DR. JUDY RONDILLA, AS OIC MEDICAL CENTER CHIEF PURSUANT TO DOH-AO 2008-0029 IMPLEMENTING HEALTH REFORM TOWARDS RAPID REDUCTION IN MATERNAL AND NEONATAL MORTALITY IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA BY REFERRING ITS PATIENT TO LAGUNA MEDICAL CENTER WHO NEED MATERNAL MANAGEMENT.

WHEREAS, an endorsement dated June 7, 2021 was received by Sangguniang Bayan Office from Melvin O. Bonza by the authority of the Mayor the agreement between Rural Health Unit of Santa Cruz, Laguna represented by Hon. Edgar S. San Luis, Local Chief Executive and Dra. Elmina DL. Monteza Municipal Health Officer and the Laguna Medical Center represented by Dr. Judy Rondilla pursuant to DOH – AO 2008-0029 is recommended to adopt the Maternal, Neonatal and Child Health Nutrition by referring its patient to Laguna Medical Center.

WHEREAS, the implementation of this MNCH is part of the process to strengthen expertise and competencies in key interventions, building partnerships and recruiting experienced field health staff are part of the investment towards more consistent maternal, newborn and child health (MNCH) and nutrition interventions. As our commitment continues as we strive to save the lives of young children and mothers focusing emergency response resources where they are critically needed.

WHEREAS, said endorsement was referred to Sangguniang Bayan Committee on Health, Nutrition and Sanitation for evaluation;
