A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ LAGUNA THE MEMORANDUM OF AGREEMENT WITH DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP) FOR THE IMPLEMENTATION OF ALTERNATIVE LEARNING SYSTEM-EDUCATION AND SKILLS TRAINING OR THE ALS-EST FRAMEWORK.

WHEREAS, a letter dated July 7, 2021 from Honorable Mayor Edgar S. San Luis to the Honorable Sangguniang Bayan respectfully endorsing for consideration and appropriate action the Memorandum of Agreement with the Development Academy of the Philippines for the implementation of Department of Education framework for the pilot implementation of the Alternative Learning System-Education and Skills Training or the ALS-EST framework;

WHEREAS, said endorsement was certified urgent due to the immediate need to release of DAP fund;

WHEREAS, for the implementation of the ALS-EST, the DAP allocated the amount of Four Million Pesos (Php 4,000,000.00) for the project and the Municipal Government of Santa Cruz Laguna has no funding component required;

WHEREAS, ALS-EST is an integrated education and skills training program which is extended to those who are out of school youth and adult learners and answers the need to promote education as provided for under section 447 [5] (x) and xi of Republic Act 7160 – Local Government Code;

WHEREAS, the terms and conditions of the Memorandum of Agreement (MOA), the same are found to be in order;

NOW THEREFORE, on motion of Hon. Ambiel John C. Panganiban (Chairman of Committee on Education and Culture), duly seconded by Hon. Lucena R. Odejar and Hon. Efren L. Diaz and with the approval of the members of the Sangguniang Bayan, it was

RESOLVED, to authorize HONORABLE MAYOR EDGAR S.
