A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) DULY REPRESENTED BY ITS REGIONAL DIRECTOR MARCELO NICOMEDES J. CASTILLO REGARDING THE DETAILS OF THE SPECIFIC IMPLEMENTATION AGREEMENT (SIA) FOR THE SUPPLEMENTARY FEEDING PROGRAM AND SUPERVISED NEIGHBORHOOD PLAY IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, health welfare is one of the fundamental responsibilities of Local Government Units toward their constituents as embodied in the Local Government Code;

WHEREAS, the DSWD, in its mandate to provide social welfare and development programs, particularly through technical assistance and resource augmentation has been providing community based nutrition programs and services such as feeding program healthy;

WHEREAS, an endorsement dated August 3, 2021 was forwarded to the Hon, Sangguniang Bayan thru Hon. Laarni A. Malibiran the Memorandum of Agreement with DSWD represented by its Director Marcelo Nicomedes J. Castillo, asking to authorize Hon. Edgar S. San Luis to enter and sign a Supplementary Agreement for Specific Implementation Agreement (SIA) for Supplementary Feeding Program and supervised neighborhood play in the Municipality;

WHEREAS, said endorsement together with the MOA was referred to the Committee on Social Welfare and Development, Family and Women for evaluation;

WHEREAS, after thorough evaluation and deliberation it was recommended for its approval that the same has been found to be in accordance with law,
