SAN LUIS IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) DULY REPRESENTED BY ITS REGIONAL DIRECTOR MARCELO NICOMEDES J. CASTILLO REGARDING THE DETAILS OF THE SPECIFIC IMPLEMENTATION AGREEMENT (SIA) FOR THE SUPPLEMENTARY FEEDING PROGRAM AND SUPERVISED NEIGHBORHOOD PLAY IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

**WHEREAS**, health welfare is one of the fundamental responsibilities of Local Government Units toward their constituents as embodied in the Local Government Code;

**WHEREAS**, the DSWD, in its mandate to provide social welfare and development programs, particularly through technical assistance and resource augmentation has been providing community based nutrition programs and services such as feeding program healthy;

**WHEREAS**, said endorsement together with the MOA was referred to the Committee on Social Welfare and Development, Family and Women for evaluation;

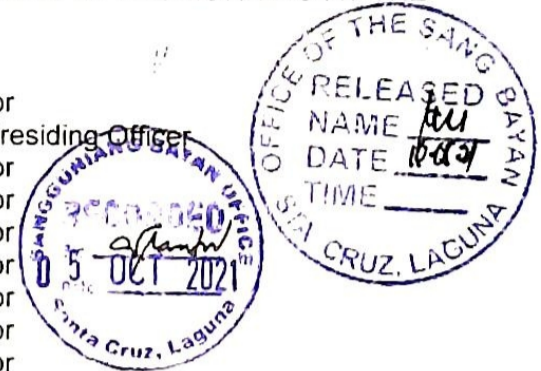
**WHEREAS**, after thorough evaluation and deliberation it was recommended for its approval that the same has been found to be in accordance with law,
