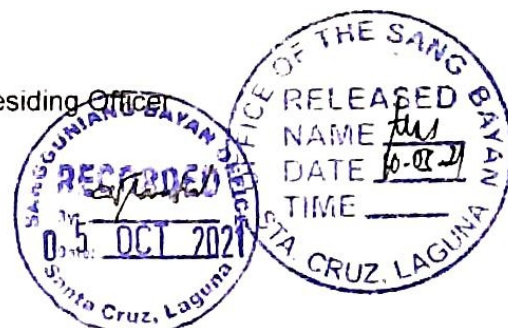

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ LAGUNA TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH DEVELOPMENT BANK OF THE PHILIPPINES (DBP) DULY REPRESENTED BY JOEL G. JALBUENA HEAD, BBG-SL TO AVAIL OF "SALARY LOAN FACILITY" WHICH PROVIDE FINANCIAL ASSISTANCE IN THE FORM OF SALARY LOANS TO QUALIFIED OFFICERS AND EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA IN ACCORDANCE WITH DBP CONSUMER LENDING ACT.**

**WHEREAS**, an endorsement from the Municipal Mayor Edgar S. San Luis dated September 15, 2021 regarding the Memorandum of Agreement with the Development Bank of the Philippines (DBP) to avail of the "Salary Loan Facility" to provide financial assistance in the form of salary loans to qualified officers and employees of the Municipal Government of Santa Cruz Laguna in accordance with DBP consumer lender;

**WHEREAS**, the request was referred to Committee on Finance, Budget and Appropriation for evaluation;

**WHEREAS**, during the deliberation it was known to the members of the Committee that it is only a renewal of agreement extending financial assistance to qualified officers and employees in the form of salary loans;

**WHEREAS**, the Sangguniang Bayan of Santa Cruz Laguna pursuant to SB Resolution has fully authorized the Municipal Mayor Edgar S. San Luis to enter and sign the Memorandum of Agreement (MOA) with Development Bank of the Philippines "Salary Loan Facility" Program;

**NOW THEREFORE**, on motion of Hon Louie C. De Leon (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by Hon. Alan T. Pamatmat, and with the approval of the members of the Sangguniang Bayan, it was
