A RESOLUTION APPROVING AND ADOPTING THE 2020 - 2022 LDRRM LOCAL CLIMATE CHANGE ACTION PLAN FOR THE MUNICIPALITY OF SANTA CRUZ, LAGUNA SUBJECT TO ALL LEGAL RULES, LAWS AND REGULATIONS.

WHEREAS, climate change is scientifically recognized as alarming global problem. It is attributed directly to global warming caused by human activities like the burning of fossil fuels used by industrialization activities of countries worldwide. These activities include worldwide deforestation, increasing industrial activity, motor vehicle emission waste management practices and intensive agriculture specifically the slash and burn farming method;

WHEREAS, pursuant to Republic Act 9729, the Climate Change Act of 2009, Local Government Units (LGU's) were tasked to serve as the frontline agencies in the formulation and implementation of Climate Change action plans in their respective areas;

WHEREAS, the need for a Local Climate Change Action Plan (LCCAP) that will lay down the strategies and action program in addressing Disaster Risk Reduction (DRR) and to formulate climate change mitigation and adaptation strategies in response to impacts confronting the Municipality at large. The LCCAP will serve as its road map towards sustainable development by minimizing, if not avoiding, the costly aftermath of catastrophic disasters on people, infrastructure and the ecosystem;

WHEREAS, Local Climate Change Action Plan covers a period of ten years subject to review every three years to coincide with the updating of Comprehensive Development Plan;

NOW THEREFORE, upon motion of Hon. Mark Anthony P. Joven (Chairman of the Committee on Environment and Natural Resources), duly seconded by Hon. Efren L. Diaz, Hon. Patrocinia S. Kalaw, and Hon, Lucena R. Odejar, and with the approval of the members of the Sangguniang Bayan, it was
