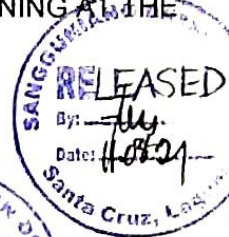

RESOLUTION APPROVING THE REALIGNMENT OF THE AMOUNT OF ONE HUNDRED FORTY ONE THOUSAND PESOS (Php141,000.00) FROM SOME OF THE UNUSED PORTION OF MAINTENANCE AND OTHER OPERATING EXPENSES- - REPAIR AND MAINTENANCE - MACHINERY AND EQUIPMENT (Php60,000.00) AND OTHER SUPPLIES AND MATERIAL EXPENSES (Php81,000.00) TO BE ALLOCATED TO FUEL, OIL & LUBRICANTS EXPENSES UNDER THE OFFICE OF THE VICE MAYOR, MUNICIPALITY OF SANTA CRUZ, LAGUNA SUBJECT TO LEGAL LAWS, RULES AND REGULATION.


