RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PLAN (SIP) FOR THE REALIGNMENT OF THE AMOUNT OF ONE HUNDRED FORTY ONE THOUSAND PESOS (Php141,000.00) FROM THE UNUSED PORTION OF MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) TO BE ALLOCATED TO FUEL, OIL & LUBRICANTS EXPENSES UNDER THE OFFICE OF THE VICE MAYOR, MUNICIPALITY OF SANTA CRUZ, LAGUNA SUBJECT TO LEGAL LAWS, RULES AND REGULATION APPROVED UNDER RESOLUTION NO. 428-S2021/APPROPRIATION ORDINANCE NO. 28-S2021.
