RESOLUTION APPROVING AND AUTHORIZING THE MUNICIPAL MAYOR HON. EDGAR S. SAN LUIS OF "CHRISTMAS TIANGGE SA PAMILIHANG BAYAN" OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA FROM DECEMBER 19 - 25, 2021 AND DECEMBER 27-31, 2021 LOCATED ON BOTH SIDES OF A. REGIDOR STREET FROM SOUTH EMERALD TO ORO RESTAURANT.

WHEREAS, on December 15, 2021, the Office of the Sangguniang Bayan received an endorsement from Municipal Mayor Hon. Edgar S. San Luis respectfully requesting to hold a Special Session for the approval of the "Christmas Tiangge sa Pamilihang Bayan" Municipality of Santa Cruz, Laguna on December 19 to 25 2021 and December 27 to 31, 2021 located on both sides of A. Regidor Street from South Emerald to Oro Restaurant in view of the limited time and urgency of the activity;

WHEREAS, aside from celebrating the Christmas holiday season it would further stir the economic activity of retailers who were affected by the pandemic, One hundred (100) slots will be available free of charge with an area of two (2) meters;

WHEREAS, said request was referred to Committee on Market and Slaughterhouse for its evaluation and recommendation;
