WHEREAS, Budget Circular No. 2021- 4 dated December 28, 2021 - Guidelines on the grant of Service Recognition Incentive (SRI) to Government Employees for FY 2021 in the amount of Ten Thousand Pesos (Php10,000.00) and Administrative Order No. 46 dated December 29, 2021 - Authorizing the grant of Gratuity Pay to Contract of Service and Job Order Workers for FY 2021 in the amount of Five Thousand Pesos (Php5,000.00) depending on the length of service which shall be sourced from savings of Maintenance and Other Operating Expenses of different Offices to Unappropriated Balance;

WHEREAS, the government continues to acknowledge all Public Servants for their collective and unceasing participation in and invaluable contribution to the establishment of streamlined government processes and responsive delivery of services to the public especially in the midst of the Prevailing Public Health Emergency due to the COVID 19 Pandemic;

WHEREAS, the grant of Service Recognition Incentive (SRI) to Government Employees for FY 2021 is in recognition of their hard work, commitment and dedication to Public Service and in addition a C grant of Performance Base Bonus as an awardee;

WHEREAS, an endorsement from Honorable Municipal Mayor Edgar S.
