A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PLAN (SIP) AUTHORIZING THE SUPPLEMENTAL BUDGET FOR THE RELEASE OF THE SERVICE RECOGNITION INCENTIVE (SRI) FOR THE YEAR 2021 AND PERFORMANCE BASED BONUS FOR THE YEAR 2020 FOR PERMANENT EMPLOYEES (Php 4,166,000.00), CASUAL EMPLOYEES (Php 1,504,000.00) AND GRATUITY PAY FOR JOB ORDER WORKERS (Php 1,790,000.00) OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA AMOUNTING TO SEVEN MILLION FOUR HUNDRED SIXTY THOUSAND PESOS (Php7,460,000.00) APPROVED UNDER SANGGUNIANG BAYAN RESOLUTION NO. 514-2021/APPROPRIATION ORDINANCE NO. 42-S2021 SUBJECT TO EXISTING LEGAL LAWS, RULES AND REGULATION

WHEREAS, Budget Circular No. 2021-4 dated December 28, 2021 - Guidelines on the grant of Service Recognition Incentive (SRI) to Government Employees for FY 2021 in the amount of Ten Thousand Pesos (Php10,000.00) and Administrative Order No. 46 dated December 29, 2021 - Authorizing the grant of Gratuity Pay to Contract of Service and Job Order Workers for FY 2021 in the amount of Five Thousand Pesos (Php5,000 00) depending on the length of service which shall be sourced from savings of Maintenance and Other Operating Expenses of different offices to Unappropriated Balance;

WHEREAS, the government continues to acknowledge all public servants for their collective and unceasing participation in and invaluable contribution to the establishment of streamlined government processes and responsive delivery of services to the public especially in the midst of the prevailing public Health Emergency due to the COVID 19 Pandemic.

WHEREAS, the grant of Service Recognition Incentive (SRI) to government employees for FY 2021 is in recognition of their hardwork, commitment and dedication to public service and in addition a grant of Performance Base Bonus as an awardee;

WHEREAS, an endorsement from Honorable Municipal Mayor Edgar S. San Luis dated December 29, 2021 respectfully requesting for a Special Session of the Sangguniang Bayan for the purpose of approving and authorizing the release of the grant of Service Recognition Incentive (SRI) including the grant of Performance Based Bonus to be allocated for Municipal Government Employees for FY 2021 in the amount of Ten Thousand Pesos (Php10,000.00 and 6,000.00 respectively) and Gratuity Pay to Contract of Service Employees and Job Order Workers for FY 2021 in the amount of Five Thousand Pesos (Php5,000.00) with a total amount of SEVEN MILLION FOUR HUNDRED SIXTY THOUSAND PESOS (Php7,460,000.00);
