RESOLUTION NO. 275- S2022

A RESOLUTION GIVING AUTHORITY TO MUNICIPAL MAYOR HON. EDGAR S. SAN LUIS TO ENTER FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO TRANSACT/NEGOTIATE, ENTER AND SIGNED INTO AN AGREEMENT WITH PHILIPPINE CHARITY SWEEPSTAKE OFFICE (PCSO) REGARDING THE REQUEST/RELEASE OF AN AMBULANCE OF THIS MUNICIPALITY.

WHEREAS, PCSO is the principal government agency mandated by law to raise and provide funds for health program, medical assistance and services and charities of national character through the conduct of sweepstakes and other similar activities;

WHEREAS, in order to complement the critical role of the Municipal Government of Santa Cruz, Laguna in ensuring the delivery of health services to the people and securing the welfare needs of its constituents, an endorsement from the Honorable Mayor Edgar S. San Luis dated April 18, 2022 requesting for a Special Session of the Honorable August Body for a resolution authorizing to transact with PCSO in order that the Municipality be a recipient of an ambulance;

WHEREAS, as a requirement to avail of this ambulance is a resolution giving authority to the Municipal Mayor pursuant to Republic Act 7160 otherwise known as Local Government Code of 1991;

NOW THEREFORE, upon motion of Honorable Councilor Mark Anthony P. Joven (Vice Chairman of Committee on Health, Nutrition and Sanitation), duly seconded by all the members present, be it
