RESOLUTION NO. 154- S2022

RESOLUTION GRANTING AUTHORITY TO MUNICIPAL MAYOR HON. EDGAR S. SAN LUIS TO SIGN MEMORANDUM OF AGREEMENT WITH LAGUNA LAKE DEVELOPMENT AUTHORITY FOR THE IMPLEMENTATION BY THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA PILOT PROJECT ENTITLED "SUPPLEMENTAL AERATION TO MINIMIZE ALGAL BLOOM IN LAGUNA DE BAY.

WHEREAS, the development and proliferation of algal blooms likely result from a combination of environmental factors including available nutrients, temperature, sunlight. Ecosystem, hydrology and water storage and water chemistry;

WHEREAS, this project aims to develop a clean Laguna de Bay through the control of this proliferation of blue-green algae;

WHEREAS, Laguna Lake Development Authority will allocate FOUR HUNDRED TWENTY THOUSAND Pesos (Php420,000.00) to the Municipal Government of Santa Cruz, Laguna for the implementation of this project subject to COA laws, rules and regulations;

WHEREAS, the Municipal Government of Santa Cruz, Laguna will designate focal person in order to work closely with the LLDA in the implementation of this project and with Barangays in monitoring the project sites;

WHEREAS, to achieve the aims of this project an endorsement dated December 16, 2021 was received by Sangguniang Bayan Office requesting to grant Hon. Mayor Edgar S. San Luis to enter into Memorandum of Agreement with Laguna Lake Development Authority that will redound to the benefit of the constituents;

WHEREAS, said endorsement was referred to the Committee on Agriculture, Fisheries and Cooperative and Committee on Natural Resources and Environment for study and deliberation;

WHEREAS, after thorough study it is recommended that an authority be granted the Municipal Mayor Hon Edgar S. San Luis to enter into MOA with LLDA;

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Chairman, Committee on Agriculture, Fisheries and Cooperative), duly seconded by all the members of the Sangguniang Bayan present, it was

RESOLVED as it is hereby RESOLVED: To grant authority to Municipal Mayor Hon. Edgar S. San Luis to sign Memorandum of Agreement with Laguna Lake Development Authority for the Implementation by the Municipal Government of Santa Cruz, Laguna Pilot Project Entitled: Supplemental Aeration to Minimized Algal Bloom in Laguna De Bay.

ORDERED: Let copies of this resolution be furnished the Honorable Mayor, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development, the Municipal Accountant, the Municipal Agriculture Office; Laguna Lake Development Authority and all other concerned offices, for their information and appropriate action.
