**A RESOLUTION GRANTING AUTHORITY TO MUNICIPAL MAYOR HON. EDGAR S. SAN LUIS TO ENTER SIGN AND RATIFY IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA A MEMORANDUM OF AGREEMENT WITH LAGUNA STATE POLYTECHNIC UNIVERSITY COLLEGE OF ENGINEERING-EXTENSION AND TRAINING SERVICES DULY REPRESENTED BY ITS UNIVERSITY PRESIDENT MARIO R. BRIONES, FOR CONDUCTING SKILLS TRAINING FOR SANGGUNIANG KABATAAN (SK), OUT OF SCHOOL YOUTH (OSY), ALTERNATIVE LEARNING SYSTEM (ALS), SENIOR CITIZENS, PERSONS WITH DISABILITY (PWD), LGBT, HOUSEHOLD AND OTHER INTERESTED CONSTITUENTS IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.**

**WHEREAS**, an endorsement dated April 21, 2022 addressed to the Honorable Members of Sangguniang Bayan duly received on April 21, 2022 with attached draft of Memorandum of Agreement with Laguna State Polytechnic University College of Engineering a request to grant the Honorable Mayor Edgar S. San Luis the authority to enter, sign and ratify a Memorandum of Agreement in conducting skills training for the Sangguniang Kabataan, Out of School Youth, Alternative Learning System, Senior Citizens, Persons with Disability, LGBT and other interested constituents of this Municipality with Laguna Polytechnic University;

**WHEREAS**, the Municipal Government of Santa Cruz, Laguna ensures to uphold the established partnership with abovementioned educational establishments to provide for the establishment and maintenance of a complete adequate and integrated system of basic education relevant to the goals of the national government;

**WHEREAS**, said endorsement was referred to the Committee on Education and Culture for study and evaluation;

**WHEREAS**, after thorough study and evaluation, it is recommended that an authority be granted the Municipal Mayor Hon Edgar S. San Luis to enter into MOA with Laguna State Polytechnic University College of Engineering-Extension and Training Services.
