RESOLUTION NO. 281- S2022

A RESOLUTION DESIGNATING HONORABLE ALAN T. PAMATMAT CHAIRMAN, COMMITTEE ON PEACE AND ORDER AND PUBLIC SAFETY, AS REPRESENTATIVE OF THE SANGGUNIANG BAYAN TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, Republic Act No. 6975 as amended by RA No. 8551 declares the policy of the state in the establishment of Philippine National Police under Reorganized Department of the Interior and Local Government Code, thus :

Section 2. Declaration of Policy – It is declared to be the policy of the State to promote peace and order, ensure public safety and further strengthen local government capability aimed towards effective delivery of the basic services to the citizenry through the establishment of highly efficient and competent police force that is national in scope and civilian in character. Towards this end, the State shall bolster a system of coordination and cooperation among the citizenry, local executives and the integrated law enforcement and public safety agencies under this Act.

Likewise, Republic Act No. 8551 declares that:

Section 2. Declaration of Policy and Principles – It is hereby declared the Policy of the State to establish a highly efficient and competent police force which is National in scope and civilian in character administered and controlled by a National Police Commission.

The Philippine National Police shall be a community and service oriented Agency responsible for the maintenance of peace and order and public safety. The PNP shall be so organized to ensure accountability and uprightness in police exercise of discretion as well as to achieve efficiency and effectiveness of its members and units in the performance of their function.

WHEREAS, Section 43 of RA No. 6975 as amended by RA No. 8551, the PLEB shall have jurisdiction to hear and decide citizen's complaints or cases filed before it against erring officers and members of the PNP. There shall be at least one (1) PLEB for every five hundred (500) city or Municipal Police Personnel.

NOW THEREFORE, on motion of Hon. Rizaldy N. Kalaw (Chairman, Committee Rules and Privilege), duly seconded by Hon. Norman T. Tolentino, Hon. Ambiel John C. Panganiban, Hon. Lea A. Almarvez, Hon. Mark Anthony P. Joven, Hon. Lucena R. Odejar and Hon. Patrocinia S. Kalaw, and with the approval of the members of the Sangguniang Bayan present, it was
