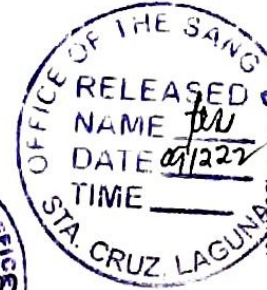

MUNICIPAL ORDINANCE NO. 07- S2022

AN ORDINANCE IMPOSING A FARE OF TWENTY PESOS (PHP 20.00) FOR THREE WHEELED VEHICLE AND FIFTEEN PESOS (PHP 15.00) FOR STUDENTS, SENIOR CITIZENS, PERSONS WITH DISABILITY (PWD), SOLO PARENT AND PREGNANT WOMEN AND ADDITIONAL PHP 5.00 FOR EVERY KILOMETER AND IMPOSING AN ADDITIONAL SAFETY MEASURE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as "Local Government Code of 1991", states that every Local Government Unit shall exercise the powers expressly granted those necessarily implied therefrom, as well as power necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare within their respective territorial jurisdiction, Local Government shall ensure and support the promotion of health and safety, maintain peace and order and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Sangguniang Bayan also has the power to approve ordinance which shall ensure the effective and efficient delivery of the basic services, approve measures and adopt quarantine regulations to prevent the introduction and spread of disease;

WHEREAS, the Municipal Government of Santa Cruz, Laguna finds it is imperative to increase the fare of tricycle for hire from the normal rate to help cushion the financial impact on drivers due to continuous oil price hike pursuant to "Standard Public Utility Tricycle Fare Increase" which adjusts the price for the utilization of the three wheeled vehicles in case there are changes in oil prices in the country;

WHEREAS, there is a need to institutionalize the mechanisms, processes and procedures in determining the changes in the fare rate and other related charges in public land transportation, thereby establish a Fare Adjustment Formula which serves as standard for the LGU in adjusting fare

NOW THEREFORE, on motion of Honorable Ambiel John C. Panganiban (Chairman of Committee on Transportation and Communication), duly seconded by Hon. Esmeraldo C. De Las Armas, Jr., Hon. Norman T. Tolentino, Hon. Rizaldy N. Kalaw, Hon. Mark Anthony P. Joven, Hon. Alan T. Pamatmat, Hon. Patrocinia S. Kalaw and Hon. Lucena R. Odejar and with the approval of the members of the Sangguniang Bayan present, it was

BE IT ORDAINED by the Sangguniang Bayan of Santa Cruz, Laguna, that:

SECTION 1. Title: AN ORDINANCE IMPOSING A FARE OF TWENTY PESOS (PHP 20.00) FOR THREE WHEELED VEHICLE AND FIFTEEN PESOS (PHP 15.00) FOR STUDENTS, SENIOR CITIZENS, PERSONS WITH DISABILITY (PWD), SOLO PARENT AND PREGNANT WOMEN AND ADDITIONAL PHP 5.00 FOR EVERY KILOMETER AND IMPOSING AN ADDITIONAL SAFETY MEASURE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

SECTION 2. Definition of Terms

Tricycle for hire – a three wheeled motorcycle (tatlong gulong) filled with side car operated to render transport service to the general public for a fee

Kautusang Bayan Blg 16-T2013 – Kautusang nagtatakda ng bagong alituntunin patakaran at panuntunan sa pagpapatupad ng Batas Trapiko sa Bayan ng Santa Cruz, Laguna.

LTO Memorandum Circular 2020-2227 which declared that L5 Symmetrically arranged Three- Wheeled Vehicles (TWV) would no longer be incorrectly registered as Motorcycle with sidecar and would be registered correctly as **Three-Wheeled Vehicles**.

Highway – refers to every public thoroughfare, public boulevard, driveway, avenue, park, alley and callejon but shall not include roadways upon grounds owned by private persons, colleges, universities or similar institutions.

Face mask- refers to a professional or an improvised cover of the mouth and nose designed to protect the wearer from catching or spreading infection.

Driver - shall mean every and any licensed operator of a motor vehicles

Student – person who is studying at a school or college in order to enter a particular profession.

Senior Citizens – an elderly person specially one who is retired and living in a person
- an older adult and specially on who is of age 60 or older.

Persons with Disability – an individual with physical or mental condition that limits a persons movements, senses or activities
- a person with physical, mental intellectual or sensory impairment that hinders his full and effective participation in society.

Solo Parent – a person who has a dependent child or dependent children and who is widowed, divorced or unmarried or an individual who is left alone with the responsibility of parenthood due to death of spouse.

Pregnant Women – having a child or other off spring developing in the body
- describe a fetus develops inside a women womb or uterus

SECTION 3. Rules and Guidelines and Measures for Three Wheeled Vehicle (Tatlong Gulong) Operators and Drivers.

3.1 imposing a fare of Twenty Pesos (Php 20.00) for three wheeled vehicle and Fifteen Pesos (Php15.00) for Students, Senior Citizens, Person with Disability (PWD), Solo Parent and Pregnant Women and additional Php 5.00 for every kilometer and imposing an additional safety measure within the territorial jurisdiction of the Municipality of Santa Cruz, Laguna.

3.2 posting of operator/driver's ID for identification or updated drivers license issued by Land Transportation Office for every three wheeled vehicle including the fare matrix issued by Municipal Treasurer's Office.

3.3 pursuant to LTO MC 2020-2227 which declared that L5 Symmetrical arranged Three- Wheeled Vehicles (TWV) would no longer be incorrectly registered as Motorcycle with sidecar and would be registered correctly as **Three-Wheeled Vehicles**.

3.4 Only the registered three wheeled vehicle with franchise is allowed to operate and pick up passengers within the jurisdiction of the Municipality of Santa Cruz, Laguna

3.5. Wearing of facial mask, and handkerchief pursuant to Municipal Ordinance No. 06- S2020 during their route / operation.

3.6. Three-wheeled vehicles in all cases shall bring with them necessary road license/document during their route / operation

3.7. Imposition of number coding scheme to ensure that only 20% of the total number of three wheeled vehicle will be in operation when the franchise number ending in the following

- 1 - 2 Monday
- 3 - 4 Tuesday
- 5 - 6 Wednesday
- 7 - 8 Thursday
- 9 - 0 Friday

3.8. Strict implementation of disinfection of the tricycle shall be done for every passenger who take its ride

SECTION 5. Penalty. Any Person who violates the provision of this ordinance shall be penalized as follows:

First Offense	-	a fine of P 500.00
Second Offense	-	a fine of P1,000.00
Third Offense	-	a fine of P1,500.00

SECTION 6. Implementing Office- The Santa Cruz Traffic Management Office / Task Force Disiplina and Philippine National Police (PNP) is tasked to implement the provision of this Ordinance. It is hereby establish a help desk for assistance and the activation of Santa Cruz Franchising Board pursuant to Kautusang Bayan Blg. 11-T2016 (Kautusang Nagtatakda ng Panuntunan at Alituntunin sa Pagkuha ng Prangkisa ng Traysikel sa bayan ng Santa Cruz, Laguna at nagpapataw ng kaukulang kaparusahan sa paglabag dito.)

SECTION 7. All Ordinances, Resolutions, Executive Orders, Memorandum Circulars and Administrative Order or parts thereof which are inconsistent with this ordinance are hereby repealed and modified accordingly.


SECTION 8. Effectivity. This ordinance shall take effect upon its approval.

ORDERED: Let copies of this ordinance be furnished the Honorable Sangguniang Panlalawigan, the Honorable Mayor, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Officer, the Municipal Accountant, Liga ng mga Barangay, Tricycle Operators and Drivers Association and all other concerned offices, for their information and appropriate action.
