A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO ENTER AND SIGN THE CONTRACT OF LEASE WITH ATTY. DOMINGO T. AÑONUEVO, OWNER OF THE PROPERTY LOCATED AT LOPEZ JAENA STREET, BARANGAY POBLACION IV, SANTA CRUZ, LAGUNA FOR A PERIOD OF ONE (1) YEAR BEGINNING AUGUST 2022 WITH A MONTHLY RENTAL IN THE AMOUNT OF TWENTY THOUSAND PESOS (Php 20,000.00), TO BE USED AS OFFICES OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT AND OTHER OFFICES, THIS MUNICIPALITY.

WHEREAS, Atty. Domingo T. Añonuevo is the owner of the property located Lopez Jaena Street, Barangay Poblacion IV, Santa Cruz, Laguna covered by TCT No. T-277754 of the Register of Deeds together with all improvements thereof;

WHEREAS, the Municipal Government of Santa Cruz, Laguna has offered to lease the above-mention property together with its improvement thereon;

WHEREAS, the Sangguniang Bayan of the Municipality of Santa Cruz, Laguna through the Committee on Social Welfare and Development, Family and Women, hereby recommend its approval.
