RESOLUTION TEMPORARILY ALLOWING STALLS OF FLOWERS AND VENDORS OF CANDLES TO OCCUPY THE STREETS ALONG A. REGIDOR STREET, OPPOSITE ROAD FROM SOUTH EMERALD TO SANTISIMA CRUZ ELEMENTARY SCHOOL LOCATED ALONG THE MUNICIPAL PUBLIC MARKET OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA FROM OCTOBER 30, 31 AND NOVEMBER 1, 2022.

WHEREAS, Sangguniang Bayan is of a receipt of a request letter from Honorable Mayor Edgar S. San Luis dated October 17, 2022 seeking assistance to allow stalls of flowers and candle vendors to occupy the streets along Regidor Street, and opposite road from South Emerald to Santisima Cruz Elementary School on October 30, 31 and November 1, 2022.

WHEREAS, the request was referred to the Committee on Market and Slaughterhouse for evaluation;

WHEREAS, after thorough evaluation and deliberation it was recommended for its approval.

RESOLVED as it is hereby **RESOLVED**: Temporarily allow stalls of flowers and vendors of candles to occupy the streets along A. Regidor Street, opposite road from South Emerald to Santisima Cruz Elementary School located along the Municipal Public Market of the Municipality of Santa Cruz, Laguna from October 30, 31 and November 1, 2022.
