## RESOLUTION NO. 421- S2022

A RESOLUTION DECLARING STATE OF CALAMITY IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA DUE TO WIDESPREAD DAMAGE AND DEVASTATION BROUGHT ABOUT BY TYPHOON "PAENG".

WHEREAS, Presidential Proclamation No. 84 dated November 2, 2022, was issued by President Ferdinand E. Marcos, Jr. "Declaring a State of Calamity in Regions IV-A, V, VI and the Bangsamoro Autonomous Region for Muslim Mindanao;

WHEREAS, the declaration of a State of Calamity will, among others:

- Hasten the rescue, recovery, relief, and rehabilitation efforts of the government and the private sector
- Effectively control the prices of basic necessities and prime commodities and afford the National Government, as well as Local Government Units (LGUs) ample latitude to utilize appropriate funds for rescue, recovery, relief, and rehabilitation efforts, and for the continuous provision of basic services to the affected populations, in accordance with law;

WHEREAS, prior to the issuance of Proclamation No. 84, the Local Chief Executive Hon. Edgar S. San Luis forwarded a letter dated November 2, 2022 requesting for a Special Session for the purpose of declaring a State of Calamity in 26 Barangays affected by the damage and devastation caused by Typhoon Paeng

WHEREAS, the continuous rains brought about by the enhanced rains due to Typhoon Paeng inundated large parts of the Municipality of Santa Cruz, affecting 16,260 families of which 1,008 families or 4,147 individuals are still in evacuation centers and with ten (10) barangays that are still underwater namely, Santisima Cruz, San Pablo Norte, Santo Angel Central, Santo Angel Norte, Duhat, Calios, Patimbao, Poblacion IV, Oogong and San Pablo Sur; and with damages on agricultural infrastructures and products including fisheries amounting to (Php1,375,000); rice (Php16,751,000) covering 246 hectares of land area;

WHEREAS, the Local Government Units are authorized under Section 16 of the Local Government Code of 1991, otherwise known as the General Welfare Clause, "xxx to exercise the powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, the letter request was referred to the Committee on Natural Resources and Environment for evaluation,

WHEREAS, after thorough evaluation, said request was recommended for approval and further recommended to be harmonized with Presidential Proclamation No. 84 S. 2022;

NOW THEREFORE, on motion of Hon. Mark Anthony P. Joven (Chairman, Committee on Natural Resources and Environment, duly seconded by all the members of the Sangguniang Bayan present, it was

RESOLVED as it is hereby RESOLVED by Sangguniang Bayan in its Special Session to Declare STATE OF CALAMITY IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA DUE TO WIDESPREAD DAMAGE AND DEVASTATION BROUGHT ABOUT BY TYPHOON "PAENG".
