RESOLUTION NO. 431- S2022

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA A MEMORANDUM OF AGREEMENT FOR INTER-LGU COOPERATION WITH THE PROVINCIAL GOVERNMENT OF LAGUNA DULY REPRESENTED BY HON. RAMIL L. HERNANDEZ, PROVINCIAL GOVERNOR OF THE PROVINCE OF LAGUNA DUE TO THE PASSAGE OF REPUBLIC ACT NO. 11223 WHICH ENCOURAGE LGU'S TO INTEGRATE HEALTH SYSTEM.

WHEREAS, in a letter of Melvin O. Bonza, Municipal Administrator by the authority of the Municipal Mayor Hon. Edgar S. San Luis dated September 20, 2022 has requested an authority by the Sangguniang Bayan to enter and sign a Memorandum of Agreement with the Provincial Government of Laguna and all the Cities and Municipalities on the other side due to the passage of Universal Health Care Act or Republic Act No. 11223;

WHEREAS, it states that the DOH, DILG, PHILHEALTH and LGUs shall endeavor to integrate health systems into Province wide health systems which emphasizes that the system shall pool and manage through a special fund all resources intended for health services. A special health fund will be set up by Provincial Health Board and LGUs shall create a sub-ledger in the existing Trust Fund Account for health,

WHEREAS, said request has been referred to the Committee on Health Nutrition and Sanitation for study and evaluation;

NOW THEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman Committee on Health, Nutrition and Sanitation), duly seconded by all the members present, it was,

BE IT RESOLVED, as it is hereby **RESOLVED** to authorize THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA A MEMORANDUM OF AGREEMENT FOR INTER-LGU COOPERATION WITH THE PROVINCIAL GOVERNMENT OF LAGUNA DULY REPRESENTED BY HON. RAMIL L. HERNANDEZ, PROVINCIAL GOVERNOR OF THE PROVINCE OF LAGUNA DUE TO THE PASSAGE OF REPUBLIC ACT NO. 11223 WHICH ENCOURAGE LGU'S TO INTEGRATE HEALTH SYSTEM.
