RESOLUTION NO. 432- S2022

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN A RELIEF PREPOSITIONING AGREEMENT IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE IV-A DULY REPRESENTED BY ITS REGIONAL DIRECTOR BARRY R. CHUA.

WHEREAS, the Municipality of Santa Cruz adopts a policy of Disaster and Reduction Mainstreaming in Local Planning, programming and budgeting, local legislation, project development implementation, monitoring and evaluation pursuant to Republic Act No. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 and establish monitoring and evaluation systems to assess the effectiveness and efficiency of the mainstreaming efforts;

WHEREAS, one important aspect of the contingency plan is to ensure adequate supply of goods and medicines that can be used as relief services and assistance for the victims during and in the aftermath of disaster and the Municipality of Santa Cruz is willing to partner with Public and Private Agencies to realize the purpose;

WHEREAS, on October 13, 2022 a request letter received by Sangguniang Bayan Office from Mr. Melvin O. Bonza by the authority of the Honorable Mayor Edgar S. San Luis respectfully requesting to issue an authority to enter into Relief Prepositioning Agreement with the Department of Social Welfare and Development to designate relief warehousing facility for relief goods;

WHEREAS, among other things are the salient feature of the agreement that the LGU shall identify a representative as point contact; properly store the goods, ensure First In, First Out policy and shall distribute goods according to the direction and policy of the DSWD;

WHEREAS, DSWD shall provide emergency food and non-food relief items to the LGU designated relief warehousing facility as emergency response preparedness measure;

WHEREAS, a Relief Prepositioning Agreement was formulated that will govern the complementary duties and responsibilities of the DSWD- Field Office IV-A and the Municipal Government of Santa Cruz, Laguna and the same has been referred to the Committee on Social Welfare and Development, Family and Women for review;

WHEREAS, after thorough evaluation of the MOA, the same is recommended of its approval;

NOW THEREFORE, on motion Hon. Lea A. Almarvez, (Chairman, Committee on Social Welfare and Development, Family and Women), duly seconded by all the members of the Sangguniang Bayan present, it was

BE IT RESOLVED as it is hereby RESOLVED to authorize THE HONORABLE MAYOR EDGAR S.
