### RESOLUTION NO. 433- S2022

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. EDGAR S. SAN LUIS TO ENTER INTO AN AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY DULY REPRESENTED BY USEC CLAIRE DENNIS S. MAPA FOR THE IMPLEMENTATION OF THE PROPOSED PROJECT ON "PHILSYS BIRTH REGISTRATION ASSISTANCE PROJECT FOR THE MUNICIPALITY OF SANTA CRUZ, LAGUNA"**

**WHEREAS**, Republic Act No. 11055 created the Philippine Identification System or "PhilSys" for the establishment of a single National Identification System to register all Filipinos and residents aliens of the Republic of the Philippines;

**WHEREAS**, RA 11055 vested the PSA primary implementation of PhilSys and empowered it to collaborate with the Local Government Units (LGU's), other agencies and GOCC's to ensure the registration and enrollment of all citizens and residents aliens in the PhilSys including the Indigenous Cultural Communities and those located in remote localities;

**WHEREAS**, the proposed project "PhilSys" Birth Registration places assistance project for the Municipality of Santa Cruz, Laguna aims to increase civil registration in marginalized far flung places;

**WHEREAS**, the Municipality of Santa Cruz, Laguna have manifested their cooperation by allowing the conduct of Mobile Registration to provide services to its constituents by assisting the processing and registering those unregistered births and other Civil Registry documents within the Municipality;

**WHEREAS**, implement Philippine Civil Registry Information System (PhilCRIS) in the mobile registration;

**WHEREAS**, said manifestation was referred to Committee on Good Governance, Public Ethics and Public Accountability for evaluation;

**NOW THEREFORE**, on motion of Hon. Esmeraldo C. De Las Armas, Jr (Chairman of the Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by all the members of the Sangguniang Bayan present, it was
