SAN LUIS OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) DULY REPRESENTED BY ITS OIC-REGIONAL DIRECTOR, MYLAH S. GATCHALIAN REGARDING THE SUPPLEMENTARY FEEDING PROGRAM FOR CHILDREN AGES 2-5 YEARS OLD WITHIN 120 FEEDING DAYS ENROLLED IN THE CHILD DEVELOPMENT CENTER AND SUPERVISED NEIGHBORHOOD PLAY IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, presented for consideration of the August Body is a letter from Melvin O. Bonza by the authority of the Municipal Mayor requesting to issue an authority to enter into a Memorandum of Agreement with DSWD regarding the Supplementary Feeding Program for Children ages 2-5 years of age enrolled in Child Development Center;

WHEREAS, the salient feature of the MOA the LGU shall submit a project proposal as the basis of the funding allocation for the 12th cycle and shall include the mode of implementation which shall ensure that funds to be used shall be for the feeding operation maintain a separate subsidiary ledger for the accounts,

WHEREAS, DSWD shall supervise the regional implementation of the Supplementary Feeding Program (SFP) and designate a focal person provide funds to the LGU and evaluate the implementation,

WHEREAS, said request letter was referred to the Committee on Health, Nutrition and Sanitation for evaluation;
