RESOLUTION NO. 446-S2022

A RESOLUTION AUTHORIZING HONORABLE EDGAR S. SAN LUIS TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE COMPONENT LGU'S FOR THE IMPLEMENTATION OF THE INTER LOCAL HEALTH ZONE CALLED PINAGPALA WITH VARIOUS PARTICIPATING HOSPITALS IN THE PROVINCE OF LAGUNA.

WHEREAS, the Department of Health (DOH), in compliance with Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and in its efforts to realize the Health Sector Reform Agenda, shall provide and augment resources in the form of technical, logistics and financial assistance to the LGU's to carry out effectively, efficiently and appropriately their devolved functions and responsibilities;

WHEREAS, pursuant to Section 13, Article X of the Philippine Constitution provides that LGU's may group themselves to consolidate or coordinate their efforts, service and resources for purposes commonly beneficial to them in accordance with law and through an appropriate ordinance;

WHEREAS, the Province of Laguna shall implement the so called PINAGPALA (LAGUNA) INTERLOCAL HEALTH ZONE commonly referred to as "PINAGPALA LHZ" which will provide quality health care and responses to all its constituents and agreed to work hand in hand in the achievement of their goal;

WHEREAS, there is a need to give the Municipal Mayor of Santa Cruz the authority to enter into a MOA with the component/participating LGU's for the implementation of the INTERLOCAL HEALTH ZONE in the Province of Laguna;

NOW THEREFORE, in view of the foregoing, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of Committee on Health, Nutrition and Sanitation), duly seconded by Hon. Alan T. Pamatmat, Hon. Ambiel John C. Panganiban, Hon. Norman T. Tolentino, Hon. Mark Anthony P. Joven, Hon. Lucena R. Odejar, Hon. Patrocinia S. Kalaw and Hon. Regine S. Regalado, it was
