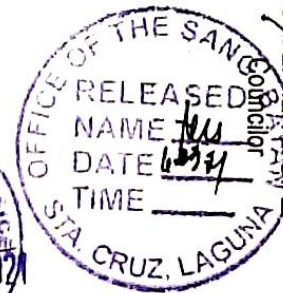

RESOLUTION NO. 300 -S2021

RESOLUTION AUTHORIZING HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER INTO A DEED OF USUFRUCT WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) REGION IV-A DULY REPRESENTED BY ITS REGIONAL DIRECTOR RD ARIEL O. IGLESIA TO GRANT SPECIFICALLY DILG PROVINCIAL OFFICE THE RIGHT TO USE THE IDLE PROPERTY OF THE MUNICIPALITY LOCATED IN BARANGAY BAGUMBAYAN, SANTA CRUZ, LAGUNA SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, endorsed to this Sanggunian by the Honorable Mayor is the request of the Department of Interior and Local Government (DILG) to grant specifically DILG Provincial Office the right to use the idle property of the Municipality located in Barangay Bagumbayan, to allotted a portion of TCT No. T-233455 and Tax Declaration No. 25-0008-00498 and Property Identification No. 023-25-0008-022-5 containing an area of more or less 400 sqm where a DILG office will be constructed;

WHEREAS, for and in consideration, the Grantor grants usufructuary the right of usufruct for a period Twenty Five Years (25) containing an area of Four Hundred square meter, a portion of TCT No. T-233455, is hereby given the right and privilege to use the subject parcel of land for the purpose of maintaining its office for the benefit of the constituents of Laguna;

WHEREAS, said endorsement was referred to Sangguniang Bayan Committee on Housing and Land Use for evaluation and study;

WHEREAS, after evaluation the same is recommended by the Committee for its approval.

NOW THEREFORE, on motion of Hon. Efren L. Diaz (Chairman of Committee on Housing and Land Use), duly seconded by Hon. Mark Anthony P. Joven, Hon. Lucena R. Odejar and Hon. Ambiel John C. Panganiban and with the approval of all the members of the Sangguniang Bayan, it was

RESOLVED: To authorize Honorable Mayor Edgar S. San Luis to enter into a Deed of Usufruct with the Department of Interior and Local Government (DILG) Region IV-A duly represented by its Regional Director RD Ariel O. Iglesia to Grant Specifically DILG Provincial Office the Right to Use the Idle Property of the Municipality Located in Barangay Bagumbayan, Santa Cruz, Laguna subject to existing Laws, Rules and Regulations.

ORDERED: Let copies of this resolution be furnished the DILG – Region IV-A represented by RD Ariel O. Iglesia; the Honorable Municipal Mayor, the Municipal Treasurer, the Municipal Budget Officer, the Municipal Accountant, the Municipal Planning and Development Coordinator; the Municipal Engineer; the Municipal Assessor, and all other concerned offices, for their information and appropriate action.
