RESOLUTION NO. 018- S2023

A RESOLUTION GRANTING AUTHORITY THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH DENR-ENVIRONMENTAL MANAGEMENT BUREAU (EMB) CALABARZON DULY REPRESENTED BY ITS REGIONAL DIRECTOR DIR NOEMI A. PARANADA IN RELATION TO ASSESSMENT, SUPPLY DELIVERY AND INSTALLATION OF BRAND NEW PRELIMINARY DISINFECTION AND STORAGE FACILITIES FOR COLLECTED COVID 19 RELATED WASTE IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, an endorsement dated November 9, 2022 from Melvin O. Bonza, Municipal Administrator by the authority of the Municipal Mayor Hon. Edgar S. San Luis addressed to the Honorable Members of the Sanggunian through Hon. Laarni A. Malibiran, Municipal Vice Mayor, forwarded a draft Memorandum of Agreement with DENR-EMB for the provision of a new 20 footer container and the 100L yellow bins and provides technical assistance;

WHEREAS, pursuant to Republic Act 9003 or the Ecological Solid Waste Management Act of 2000, that the DENR shall provide technical and other capability building assistance and support to the LGU's in the development and implementation of Local Solid Waste Management Plans and Programs;

WHEREAS, the preliminary disinfection and storage facilities project will address the challenges of improper collection, preliminary disinfections and storage of Personal Protective Equipment such as syringes and other COVID-19 related healthcare wastes;

WHEREAS, the Municipal Government of Santa Cruz, Laguna is one of the recipient of the facility of a 20-footer container van with a 4.5 ton minimum storage capacity that will provide preliminary disinfection and storage of healthcare waste;

WHEREAS, said request has been referred to the Committee on Natural Resources and Environment for study and evaluation,

WHEREAS, after thorough evaluation the request has been recommended by the committee for its approval;

NOW THEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by Hon. Lucena R. Odejar, Hon. Mark Anthony P. Joven, Hon. Norman T. Tolentino and Hon. Ambiel John C. Panganiban, and with the approval of the members of the Sangguniang Bayan, it was

RESOLVED as it is hereby RESOLVED: To grant Authority the Honorable Mayor Edgar S. San Luis to Enter and Sign A Memorandum of Agreement on Behalf of the Municipal Government of Santa Cruz, Laguna with DENR-Environmental Management Bureau (EMB) Calabarzon Duly Represented by its Regional Director Dir. Noemi A. Paranada in Relation to Assessment, Supply Delivery and Installation of Brand New Preliminary Disinfection and Storage Facilities for Collected COVID- 19 Related Waste in the Municipality of Santa Cruz, Laguna.
