RESOLUTION NO. 009- S2023

A RESOLUTION EXTENDING THE DEADLINE OF PAYMENT OF BUSINESS TAXES AND THE ISSUANCE OF MAYOR'S PERMIT FROM JANUARY 21, 2023 TO MARCH 31, 2023 TO COMPLY WITH ARTA DIRECTIVE OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, due to the risk of COVID-19 and to prevent the crowding of different offices in charge in the issuance of Mayor's Permit, Municipal Administrator Melvin O. Bonza with the authority of the Municipal Mayor Hon. Edgar S. San Luis has respectfully and favorably endorsed to the Honorable Sangguniang Bayan members dated December 9, 2022 to extend the deadline of payment of Business Taxes and the issuance of Mayor's permit;

WHEREAS, it is a yearly event and a fast and easy processing method for the application of individuals who are seeking licenses and permit in their business venture, a periodic event held every year beginning January;

WHEREAS, such extension will enable the Municipal Government to comply with the directive of ARTA (Anti Red Tape Authority) in order to eliminate the governments bureaucracy and the reduction of face to face transactions and which will enable the taxpayers to adequately prepare their finances;

WHEREAS, said request was referred to the Committee on Laws and Ordinances for their study;
