A RESOLUTION GRANTING THE HONORABLE MAYOR EDGAR S. SAN LUIS THE AUTHORITY TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA A LETTER OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE – PHILRICE DULY REPRESENTED BY ITS DA-PHILRICE DIRECTOR AT LOS BAÑOS, RHEMILYN Z. RELADO-SEVILLA A CONTINUATION OF THE SEED PROJECT DESIGNED TO IMPROVE RICE PRODUCTS OF FARMERS IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, the Department of Agriculture is an agency of the government charged with, among others in ensuring the nation with adequate supply and distribution of grains as we continue to serve our rice farmers continuously distributing certified seeds under Palay Sikatan in order to improve the yields of rice farmers via utilization of high quality seeds through appropriate crop management technologies;

WHEREAS, presented to the August Body for appropriate action is the request of the Municipal Mayor Hon. Edgar S. San Luis to grant the authority to sign a Letter of Agreement with the Department of Agriculture – PHILRICE aimed at increasing rice farmers' income and improving their competitiveness that will ensure that our collective gains are ultimately sustained and built upon over time;

WHEREAS, upon scrutiny of the Body on the Letter Agreement, it is hereby recommended for its approval.

NOW THEREFORE, on motion of Hon. Norman T. Tolentino (Chairman, Committee on Agriculture, Fishery and Cooperative), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Mark Anthony P. Joven, and Hon. Esmeraldo C. De Las Armas, Jr. and with the approval of the members of the Sangguniang Bayan, it was

San Luis the Authority to enter into and sign for and in behalf of the Municipal Government of Santa Cruz, Laguna a Letter of Agreement with the Department of Agriculture – Philrice duly represented by its DA-Philrice Director at Los Baños, Rhemilyn Z. Relado-Sevilla a continuation of the Seed Project designed to Improve Rice Products of Farmers in the Municipality of Santa Cruz, Laguna.
