A RESOLUTION GRANTING AUTHORITY TO HONORABLE EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO ENTER AND SIGN A MEMORANDUM OF PARTNERSHIP WITH PHINMA-UNION COLLEGE OF LAGUNA DULY REPRESENTED BY ITS CHIEF OPERATING OFFICER (COO) MR. EDUARDO Y. AREVALO RELATIVE TO THE HAWAK – KAMAY EDUCATIONAL ASSISTANCE.

WHEREAS, for the consideration of the Honorable Body is an endorsement dated January 12, 2023 from Honorable Mayor Edgar S. San Luis requesting to grant authority to enter and sign a Memorandum of Partnership in behalf of the Municipal Government of Santa Cruz, Laguna with PHINMA-Union College of Laguna relative to Hawak Kamay Educational Assistance;

WHEREAS, the parties hereby bind themselves to undertake the Memorandum of Partnership for the purpose of supporting the scholarship program under Hawak Kamay Educational Assistance for the incoming first year qualified students who will enjoy a 50% discount on Tuition and Miscellaneous Fees for 4 to 5 years depending on the life of the course without maintaining any grade and will be implemented within their jurisdiction;

WHEREAS, the allocated slots as agreed upon during its discussion is 52 students distributed from among 26 barangays of the Municipality of Santa Cruz, Laguna;

WHEREAS, the MOA was referred to the Committee on Education and Culture and Committee on Finance Budget and Appropriation for their study;

WHEREAS, cognizance of the need of the students under Hawak Kamay educational assistance, this Honorable Body interposes no objection;

NOW THEREFORE, on motion of Hon. Lea A. Almarvez, (Chairman Committee on Education and Culture), duly seconded by Hon. Mark Anthony P. Joven, Hon. Ambiel John C. Panganiban, Hon. Norman T. Tolentino and Hon. Esmeraldo C. De Las Armas, Jr. and with the approval of the members of the Sangguniang Bayan, it was

San Luis In Behalf of the Municipal Government of Santa Cruz, Laguna to Enter and Sign a Memorandum of Partnership with PHINMA-Union College of Laguna duly Represented by its Chief Operating Officer (COO) Mr. Eduardo Y. Arevalo, Relative to The Hawak – Kamay Educational Assistance .
