**RESOLUTION NO. 016- S2023**

**A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA AND PYROTECH SOLUTION AND INTEGRATED SERVICES CORP. DULY REPRESENTED BY ITS BRANCH MANAGER, TEODORO B. GENER JR. FOR THE TRANSPORT AND DISPOSAL OF HAZARDOUS WASTES.**

**WHEREAS**, all hazardous wastes shall be managed in accordance with existing local regulations specifically the disposal of hazardous chemical waste and disposal of potentially infectious waste by conducting periodic audits of hazardous waste and waste streams by properly segregating incompatible wastes in a safe and legal manner;

**WHEREAS**, the success of the undertaking does not only depend on the efforts of the Local Government Units but also on the active participation and cooperation of the households, business establishments and institutions within its vicinity;

**WHEREAS**, on November 9, 2022, the Honorable members of the Sangguniang Bayan received an endorsement from Melvin O. Bonza, Municipal Administrator with the authority of the Municipal Mayor Edgar S. San Luis requesting to grant authority to sign MOA with Pyrotech Solution and Integrated Services Corp. to transport and dispose hazardous waste aligned with disinfection and treatment of hazardous waste;

**WHEREAS**, said request was referred to the Committee on Natural Resources and Environment for evaluation;

**WHEREAS**, after proper study and evaluation the request is recommended for approval.
