RESOLUTION NO. 159-S/2000

RESOLUTION REQUESTING THE PRESIDENT AND/OR THE CHIEF EXECUTIVE, MANILA ELECTRIC COMPANY THAT AN ELECTRIC METER BE INSTALLED FOR EACH STALL OF THE NEW SANTA CRUZ PUBLIC MARKET, SANTA CRUZ, LAGUNA FOR THE WELFARE AND BENEFIT OF THE STALLHOLDERS.

WHEREAS, the Sangguniang Bayan in session assembled is fully aware and cognizant of the importance and significance of seeking the demands of public service by attending to the felt need of the stallholders in acquiring electric meters and having them installed in their respective stalls;

WHEREAS, the Municipal Government of Santa Cruz, Laguna is willing to shoulder the necessary expenses in the installation of electric lines from the stall to the designated area where these meter base is to be placed;

WHEREAS, the municipal government has no funds to shoulder the cost of electric consumption by the stall holders;

WHEREAS, there is an unending problem and controversy with regards to the electric consumption of hundreds of stalls if they pass to only one meter;

WHEREAS, each stallholder consumes different amounts of electricity;

WHEREAS, when the government surrenders its meter the stallholders will not have electric services;

NOW, THEREFORE, on motion of Hon. Coun. Jaime Alexander T. Calupitan, duly seconded by Hon. Councilor Louie C. de Leon and with the unanimous approval of all the members present, it was

RESOLVED: To request the President and/or the Chief Executive, Manila Electric Company that an electric meter be installed for each stall of the new Santa Cruz Public Market, Santa Cruz, Laguna for the welfare and benefit of the stall holders.
