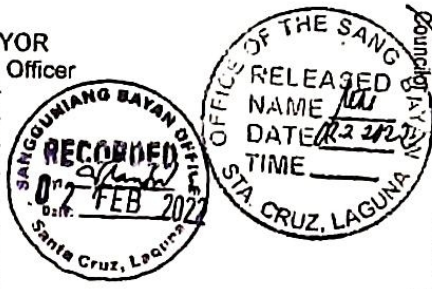

MUNICIPAL ORDINANCE NO. 03- S2022

AN ORDINANCE AMENDING SECTION 31.02 (b) (f) OF ARTICLE I - IMPOSITION OF FEES OF FRANCHISES AND OTHER FEES ON TRICYCLE OPERATION OF MUNICIPAL ORDINANCE NO. 1 SERIES OF 2012 ENTITLED "THE REVENUE CODE OF THE MUNICIPALITY OF SANTA CRUZ LAGUNA".

WHEREAS, in order to protect the public from financial collapse due to pandemic, the Local Chief Executive Hon. Edgar S. San Luis of the Municipality of Santa Cruz, Laguna have taken recovery measures and developed affordable alternatives to ensure the financial sustainability of the transport group who are facing financial distress has offered financial packages to help the transport service providers which include amendment on the Imposition of Fees on Franchises and Other Fees on Tricycle Operation;

WHEREAS, on January 10, 2022, an endorsement calling for a Special Session was favorably endorsed to the Honorable Members of the Sangguniang Bayan requesting for the amendment of the Municipal Ordinance on the Imposition of Fees on Franchise Fee for the Operation of Tricycle for hire which aimed to grant assistance to our tricycle drivers during this time of pandemic,

WHEREAS, said endorsement was referred to the Committee on Transportation and Communication for further evaluation and deliberation,

WHEREAS, during the deliberation on January 13, 2022, it was recommended and moved not to collect sticker fees amounting to One Hundred Twenty Pesos and Thirty Centavos (Php120 30) and a reduction of the Annual MTOP fees from P220.00 to P110.00, hence its approval,

NOW THEREFORE, upon motion of Hon. Ambiel John C. Panganiban (Chairman of Committee on Transportation and Communication), seconded by all the members of the Sangguniang Bayan, it was,

Be it ordained by Sangguniang Bayan of the Municipality of Santa Cruz Laguna in its Special Session assembled that:

SECTION 1. Section 31 -02 (b) (f) Article I of Municipal Ordinance No 01 Series of 2012, is hereby amended to read as follows

SECTION 31.02. Imposition of Fees – There shall be collected an Annual Franchise fee for the operation of tricycles for hire as follows

(a) Filing Fee	P 33 00
(b) Annual MTOP Fee	110 00
(c) Fare Adjustment Fee for Fare Increase	22 00
(d) Filing Fee for Amendment of MTOP	33 00
(e) Confirmation as Grantee of MTOP	22 00

SECTION 2 Repealing Clause – All Local Ordinances, rules and regulation or part thereof that are inconsistent with the provision of this Ordinance are hereby repealed or modified accordingly

SECTION 3. Effectivity This Ordinance shall take effect upon approval


