RESOLUTION RATIFYING THE CONTRACTS FOR THE CONSTRUCTION OF PROPOSED FRUIT STALLS (19 UNITS) PHASE I, SANTA CRUZ PUBLIC MARKET IN THE AMOUNT OF P409,300.00; PROPOSED EXTENSION OF GROCERY STALL, PHASE I, SANTA CRUZ PUBLIC MARKET IN THE AMOUNT OF P286,683.47; ELECTRICAL INSTALLATION/CONCRETE PRIVATE POLE, COCONUT PRODUCT SECTION, SANTA CRUZ PUBLIC MARKET IN THE AMOUNT OF P152,150.00; AND PROPOSED INSTALLATION OF SIXTEEN (16)-UNIT LAMP POSTS, PHASE I, SANTA CRUZ PUBLIC MARKET IN THE AMOUNT OF P184,975.00.

Public Market in the amount of P184,975.00
